

E-CPI ENAGroup Consumer Price Index, October 2021

ENAGroup Consumer Prices rose by %6,90 in October

ENAGroup Consumer Price Index calculated using daily price data increased by %6,90 in October 2021 (from 30.09.2021 to 31.10.2021)

October 2021, The graph below shows that the pattern of E-CPI (ENAGroup Consumer Price Index), ISE100 (Istanbul Stock Exchange), USDTRY (US Dollar-Turkish Lira Exchange Rate), and T-Bond (2-Year Turkish Treasury Bond).



ENAGroup Consumer Price Index (E-CPI) and Inflation Rates of Sub-Consumption Bundles (Based on TURKSTAT Classification)

The graph below presents the inflation rates of sub-consumption bundles.


ENAGroup observes that the prices decline in bundles of Communications by -%3,57. A sharp increase has been experienced in Miscellaneous Goods/Services by %14,77.



Inflation Rates for Micro-Consumption Bundles

For inflation rates that effectively represent the consumption habits and bundles of the different income groups, ENAGroup calculates the inflation rates for micro-consumption bundles and presents them below.

Statistics indicate that the corresponding inflation rates vary significantly. In October, we see that subgroup of Wheat Product decreased, and Snacks has increased significantly.
